

## TERMS AND CONDITIONS OF SO-LINA AUCTION MARKET, INC.

1. **THERE ARE NO GUARANTEES ON ANYTHING SOLD ON THESE PREMISES.** Look it over before you buy it. Once you buy it, it's yours. Pay for it and take care of it.
2. Any group (or lot) of items you pull aside to bid on is subject to be "picked from". If anybody wants an item sold separate out of that lot, it will be sold separate
3. Items "being picked" are to be "PULLED ASIDE" and not moved from row to row or lot to lot! Boxlots are consigned and unloaded ...not "made-up". DO NOT MAKE YOUR OWN BOXLOTS!!
4. STEALING WILL NOT BE TOLERATED. If you are caught you will be banished from the premises and subject to prosecution. If you see any stealing taking place, please notify an auctioneer or other staff member, immediately! Any questionable activity will be settled by videotape!
5. This is an absolute auction, with the exception of trailers and titled vehicles. We charge \$20.00 if not sold; standard commission if item sells.
6. Inside consignments are accepted Thursday from 8 until 2:00 pm. Inside and outside consignments are accepted Friday from 8:00 am till 2:00 pm. You can also bring consignments Monday morning from 7 till 9. The commission rate on items sold is 20%. Single items bringing \$100.00 - \$499.00 will be commissioned at 15%. Single items bringing \$500.00 or more will be commissioned at 10%.
7. Items consigned should be laid down, as opposed to being stood up, propped up or leaned up. PLEASE BE CAUTIOUS!!
8. All consignors are responsible for removing from our premises abandoned items from their consignment.
9. If rain is in the forecast, it would be best to hold off on any outside unloading. If you do unload and there is any chance of rain....protect your load from the weather!
10. You MAY NOT bid on your own merchandise!
11. **We consider this to be a cash auction. In order to get a check approved, you must present a letter from your financial institution on their letterhead. Information must state that your account is at least one (1) year old with no returned checks. (Letter should include your banks phone number).**
12. A cashier follows the auctioneer and you can pay cash as you buy. You can leave a cash deposit in the office of at least \$100.00. Leaving cash deposit will allow you to receive a receipt for your purchases. Your cash deposit must at all times be greater than your purchases; you will be paged to the office if you exceed your cash deposit.
13. So-Lina Auction charges a 10% buyer's premium for all purchases.
14. You must pay for anything charged to you. If there is a mistake made, say so immediately.
15. As soon as you buy something it is your responsibility. Pay for it and take care of it.
16. The tables for smalls are reserved one (1) week in advance. We start reserving on Monday morning for the following Monday. The items must be on your table by 11:00 AM the day of the sale. If we haven't heard from you by then, we will give your table to the next person in line.
17. When collecting for items sold or paying for purchases made, we ask that you give us thirty minutes after your last transaction before settling up.
18. You must pay SC sales tax on all purchases UNLESS you have filed your tax number in our office. South Carolina will honor out of state tax ID numbers.
19. We don't go to your place of business to solicit customers, don't come here to solicit customers.
20. NO MEAN DOGS. All dogs must be on a leash.
